The Synergize GBA Forum 2021 aims to facilitate communication and collaborations among government departments, regulators and senior executives to create long-term sustainable value in the Greater Bay Area. EY representatives and a distinguished panel of speakers will explore the following:

How will China's environmental goals create opportunities in the region?

The Guangdong-Hong Kong-Macao Greater Bay Area (GBA) plays a prominent role in the opening up of the Chinese economy. As a bridgehead of the Belt and Road Initiative, the GBA has access to China's huge domestic market and serves as an important link to the ASEAN countries, fulfilling a unique role in the nation's dual circulation strategy.

In 2021 we saw the start of the 14th Five-Year Plan, kicking off an active and steady development of the GBA into an international technology and innovation hub. We are already seeing a strong foundation for an international first-class bay area and world class city cluster.

To support an integrated development of the GBA that is in line with the nation's 14th Five-Year Plan requires a synergy across various components. Hong Kong's cooperation with other cities in the GBA is also pivotal.

The Synergize GBA Forum 2021 will be our first hybrid event in the GBA with an in-person and virtual component. The in-person physical events will be run out of two locations: Hong Kong and Shenzhen where we will connect speakers from both cities in engaging discussions. All sessions will be streamed live to a wider audience in Asia-Pacific to offer the best of live and digital experiences.
